NARRATIVE:

On Thursday, March 13, 2014, at about 1930 hours, the Palm Beach County Sheriff's Office received a 911 call that two people had been stabbed at Jimmy The Greek Taverna Restaurant located at 8221 Glades Road, Boca Raton, Palm Beach County, Florida.

Responding Palm Beach County Sheriff's Deputies were told by the dispatcher that the black male suspect, an employee of said restaurant, fled on foot dressed in a black apron with a large knife. Deputies located and apprehended the black male defendant, Tilus Lebrun, date of birth 04/22/71 in the 8000 block of Glades Road.

When I arrived at the 8000 block of Glades Road, your Affiant spoke with Deputy Similien who had Tilus Lebrun in his patrol car. Upon making contact with him, Tilus Lebrun asked Deputy Similien if he was Haitian. After telling him he was, Tilus Lebrun spontaneously uttered to him in Creole "I killed him because he took my photograph on March 2nd (unknown year) and posted it on the internet." I then left the scene and drove to the incident location. It was at that time your Affiant learned of a second victim, an unidentified Spanish male had also been transported to Delray Medical Center for treatment.

Investigators learned that the two victims, business owner, white male Dimitrios Karaloukas, date of birth 01/23/53 and the unidentified Spanish male and employee of said business had been stabbed numerous times by Tilus Lebrun.

Upon interviewing several employees of the business and patrons who were dining, detectives learned at about 1930 hours, the victim was sitting in the restaurant when Tilus Lebrun attacked him with a knife. Tilus Lebrun walked up to Dimitrios Karaloukas and for no apparent reason began stabbing him. After being stabbed three times on the left side of his torso and once in the back, Dimitrios Karaloukas exited the restaurant as did the patrons of the restaurant. It is unclear at this time when Tilus Lebrun stabbed the unidentified Spanish male victim. However, I was notified while



on scene that Dimitrios Karaloukas died from his injuries at 2046 hours and the unknown Spanish male victim was undergoing lifesaving surgery.

After leaving the scene I drove to PBSO Head Quarters. Tilus Lebrun was escorted to the interview room and began speaking to Deputy Similien in Creole. Deputy Similien told me that Tilus Lebrun said "They need to learn how to respect people; I have three kids in Haiti. I know they will suffer but they will survive."

Deputy Similien also told me while transporting Tilus Lebrun from the scene to PBSO Head Quarters, Tilus Lebrun kept repeating that he had killed the victim because the victim had taken a photograph of him without his permission.

Based on the above facts, your Affiant has probable cause to believe the Defendant, in a premeditated manner stabbed Dimitrios Karaloukas causing his death. Tilus Lebrun also stabbed the unknown Spanish male several times gravely injuring him. Your Affiant believes the Defendant was solely responsible for these actions, which are in violation of F.S.S. 782.04(1)(a)(1) First Degree Murder and F.S.S. 782.04(1)a)(1) Attempted First Degree Murder.
