


(Specifically include facts constituting cause for arrest.)</p> <p>On 3-11-19 at approximately 1150hrs D/S Rainey 8540 responded to 10981 Haydn Drive unincorporated Boca Raton in reference to a residential alarm. Upon arrival D/S Rainey located forced entry to a rear door where the glass was shattered from within and the door left in an open position. Units made entry into the interior of the residence and located further signs of a burglary where draws were open and the master bedroom was ransacked.</p> <p>While waiting for the victim Annette Grant Walker to arrive home, a canvass of the area was completed. Units discovered a white grocery bag containing jewelry boxes filled with miscellaneous jewelry, paperwork belonging to the victim and a brown blanket later deemed to be removed from the victim's residence.</p> <p>The victim Annette Grant Walker later confirmed that these items belonged to her and further accessed her home video surveillance footage. It was that at 1144hrs this date a Yellow Cab #730 pulled into the victim driveway. A male subject, later identified as defendant #1 Marcos Salas, exited the rear of the cab. A female subject later identified as Laura Holliday further exited the cab. Salas proceeded to the rear of the residence and Holliday was observed walking to the mailbox at the end of the driveway and was observed opening it. No items were removed from within. Both subjects then entered a rear screened in pool enclosure and were observed pulling on sliding glass doors handles and attempting to open windows. When none were found to be unlocked Salas then selected a pool skimmer pole and proceeded to aggressively strike a rear door multiple times until the glass was shattered from within. Salas was observed reaching through the opening and unlocked the door. Both subjects entered the interior of the residence where they spent approximately 5 minutes inside ransacking the interior and selecting property belonging to the victim. At 1157hrs both subjects exited the interior residence through the same point of entry and further exited the screened in pool enclosure. It should be noted that Salas was carrying a brown blanket containing the victim's property.</p> <p>Upon being assigned this case for follow up investigation I contacted Yellow Cab of Broward County. Upon speaking with management it was determined that a female named Laura requested a taxi for a pick up at 1940 NE 49th Street Pompano Beach FL. A contact telephone number was given of 954-770-5912. Yellow Cab #730 responded and drove the subjects to the victim's residence in Boca Raton. Investigative leads revealed that telephone # 954-770-5912 belonged to the defendant #2, Laura Holliday. Victim Grant Walker contacted various news stations and further released the video surveillance footage. Palm Beach County Crime Stoppers received tips indicating the identity of the female in the video surveillance footage as Laura Holliday as well as her maiden name of Laura Nestor. These tips were documented under Tip ID # 324-C9473 and Tip ID # 324-C9489. Further review of Holliday's open Facebook page it was discovered that she has a unique tattoo on the inside of her right forearm and second tattoo was located on her right outer calf area. These tattoos were observed on the video surveillance footage provided by the victim.</p>

(Specifically include facts constituting cause for arrest.)</p> <p>Palm Beach County Crime Stoppers received an additional tip indicating the identity of the male subject in the video surveillance footage. Tip ID # 324-C9473 identified Marcos Salas as the male subject in the video surveillance footage. I further made contact with Salas's twin sister Crista Brannon, who wrote a sworn statement indicating that the male subject observed on video was her twin brother Marcos Salas.</p> <p>On 3-18-19 I received a phone call from Crista Brannon indicating that Marcos Salas is currently at their mother's residence of 21911 White Pine Terrace. I further met with their mother Christine French who provided me a key to her residence and signed consent to search form allowing us access to her residence. Units further responded to the residence where we placed Marcos Salas under arrest without incident. Salas was transported to PBSO District 7 Substation for the purpose of interview. In a post Miranda interview Salas confessed to the fact that he and friend Laura Holliday were picked up by a Yellow Cab from 1940 NE 49th Street Pompano Beach. The two proceeded to the victim's residence where he states that Holliday explained that a friend lives at this home and it was okay to force entry into the interior. Salas stated that he forced entry into the interior by using the pool skimmer pole and strike the glass multiple times until the glass shattered. Salas admitted to going through the victims personal property and removing it from within. Salas was shown the video surveillance footage where he identified himself and Laura Holliday. Salas further escorted Detectives to residential communities surrounding the victim's neighborhood for the purpose of locating jewelry belonging to the victim. Approximately 15 additional pieces of jewelry were recovered and positively identified as belonging to the victim.</p> <p>Due to the above described events Probable Cause exists to charge Marcos Salas and Laura Holliday with Burglary to an unoccupied dwelling in violation of FSS 810.02(3b), Grand Theft in violation of FSS 812.014 (2c3), and felony Criminal Mischief in violation of FSS 806.13(1b3).</p>
