Probable Cause Affidavit

Before me this date personally appeared SLAGLE-GRANT, SHERRY L. (11631) who being first duly sworn deposes and says that on 10 day of March, (year) 2019 at 3300 W HILLSBORO BLVD, DEERFIELD BEACH, FL 33442 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On-scene investigation revealed that the SUSPECT, RAPHAEL CANDIDO VILELA, who is under the age of 21, was the operator of a white 2005 BMW 530i, bearing FL tag # JIKX61, owned by ANTONIO VILELA JUNIOR and MARILENE CANDIDA DE SOUZA VILELA, traveling westbound on Hillsboro Boulevard approaching the intersection of Country Club Boulevard.

VICTIM, SEBASTIAN ESPINOZA was the operator of a black 2018 Tesla Model 3, bearing FL temporary tag # CJR5147, owned by CECILIA MARIETTA MARTINEZ, traveling eastbound on Hillsboro Boulevard approaching the intersection of Country Club Boulevard preparing to turn left turn to travel north. SEBASTIAN ESPINOZA proceeded to turn left (north) and began crossing the westbound lanes of Hillsboro Boulevard. While making the left turn, he was struck by the BMW being driven by RAPHAEL CANDIDO VILELA, in an angular type of collision.

Based on the physical evidence at the scene, the preliminary investigation determined RAPHAEL CANDIDO VILELA was operating his vehicle at a minimum speed of ninety-five (95) miles per hour (mph) at the time of the crash. The posted speed limit on Hillsboro Blvd in the area of the crash is 45 mph. RAPHAEL CANDIDO VILELA was traveling at a minimum of 50 mph above the posted speed limit of 45 mph.

The impact of the crash caused the Tesla to redirect in a northwesterly direction where it came to final rest approximately one hundred ten (110) feet on the west side shoulder of Country Club Boulevard. The BMW continued west striking curbs, entering onto the median, colliding with shrubs and trees until the BMW came to final rest approximately six hundred ninety (690) feet west of the area of collision. The BMW and Tesla suffered catastrophic damage as a result of the crash.

Probable Cause Affidavit

Before me this date personally appeared SLAGLE-GRANT, SHERRY L. (11631) who being first duly sworn deposes and says that on 10 day of March, (year) 2019 at 3300 W HILLSBORO BLVD, DEERFIELD BEACH, FL 33442 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

The crash resulted in non-life-threatening injuries to SEBASTIAN ESPINOZA, the driver of the Tesla, and the death of THAIS HAUG who was seated in the right front passenger seat position of the Tesla.

At the time of the crash there were four (4) occupants in the BMW: RAPHAEL CANDIDO VILELA the driver, JUVENILE VICTIM, G.S. who was seated in the front right seat position, JUVENILE VICTIM, A.S. who was seated in the driver side rear seat position, and JUVENILE VICTIM, J.C. who was seated in the passenger side rear seat position.

G.S. suffered serious bodily injury as a result of the crash consisting of a broken right ankle and a broken left arm which required surgery. Prior to being transported to surgery, I briefly spoke to G.S. who stated she was seated in the right front passenger seat of the BMW while RAPHAEL CANDIDO VILELA was driving the BMW when the crash occurred. No further information was able to be obtained from G.S. at this time because she was being transported for immediate surgery.

A.S. suffered serious bodily injury including a collapsed lung. A.S. reported being seated in the driver side rear passenger seat provided a Post-Miranda sworn statement. A.S. stated on Saturday, March 09, 2019, at approximately 2300 to 2330, RAPHAEL CANDIDO VILELA had driven her, G.S., and J.C. in the BMW to attend a birthday party at an undetermined location in Pompano Beach, Broward County, Florida. At the party, RAPHAEL CANDIDO VILELA brought a bottle of "Black Label" Whiskey, and everyone began to enjoy the whiskey. A.S. stated RAPHAEL CANDIDO VILELA had drank "a lot" of whiskey while at the party. A.S. defined "a lot" as more than three (3) whiskey drinks mixed with Coconut

Probable Cause Affidavit

Before me this date personally appeared SLAGLE-GRANT, SHERRY L. (11631) who being first duly sworn deposes and says that on 10 day of March, (year) 2019 at 3300 W HILLSBORO BLVD, DEERFIELD BEACH, FL 33442 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Water in plastic cups similar to that of a red plastic "Solo" style cups. Each whiskey drink was poured in the aforementioned cup and filled a little less than half way each time the drinks were poured. A.S. stated prior to leaving the party at approximately 0300 hours, RAPHAEL CANDIDO VILELA was acting abnormal and not good to drive because she believed he was drunk. A.S. said she knew he was drunk because his speech was repetitive and slurred and not normal. A.S. stated that they tried to have another friend drive the car, but RAPHAEL CANDIDO VILELA resisted and got in the driver seat and proceeded to drive them home. Just prior to the crash, A.S. stated that RAPHAEL CANDIDO VILELA was not driving very safe and that he was driving at an excessive rate of speed. A.S. stated that all the occupants in the vehicle, kept telling RAPHAEL CANDIDO VILELA to slow down and not drive so fast because it was not safe and they could crash and within a short time, the crash occurred.

A.S. further stated in which position each of the occupants of the BMW were seated: RAPHAEL CANDIDO VILELA was the driver of the BMW; G.S. was seated in the right front passenger seat position, A.S. was seated in the left rear passenger seat position, and J.C. was seated in the passenger side rear seat position. Her statement was consistent with the physical evidence.

J.C., who was admitted into the ICU, suffered serious bodily injury consisting of multiple brain bleeds and was unable to provide a statement because he was intubated and was going to require neurosurgery to repair the bleeding on his brain.

Detective Sean Strzalkowski made contact with RAPHAEL CANDIDO VILELA. RAPHAEL CANDIDO VILELA appeared very confused, his eyes were red bloodshot and glassy, and his speech
